



Text answers:

Kayak launch would be nice but not at the proposed location at the end of newcomer (monarch butterfly habitat and very shallow channel much of the year). Perhaps the launch could be relocated to the south end of the existing sand beach. Please no new parking. I have never seen the lot at newcomer full- rarely has more than a few cars there. Please no additional turf or sand beaches. Please prioritize the natural aspect of the park to allow the birds and wildlife to flourish. Please do not indiscriminately use herbicides. There are currently vast swathes in the buffer against houses (near newcomer) where nothing but tumbleweeds grow after application of herbicides. Maintenance of existing park facilities important (more trash cans or empty them more frequently during summer months). Pickle ball very noisy and not harmonious with a relaxing park experience.

Speed limit signs needed on bike paths; some go dangerously fast. Need stop signs and crosswalks where cars cross paths. More patrols needed to decrease vandalism and fires. Improve habitat rather than clearing what's there.

Sections of the bike trail are so bumpy it feels like my teeth will get rattled loose.

The parking lots, especially the large northern parking lot on River Road, can feel very threatening. Full of rowdy teenagers getting drunk or high, feels unsafe to have the bike path go through a bunch of distracted hot rod/muscle car drivers. Is there a way to close the parking lots overnight and not route the bike path through car traffic? Turning parts of the parking lot back into green space also sounds like a good idea.

Love the idea of reducing the invasive plants and replacing them with natives!

I would like to see careful vegetation management. The strip along the river provides habitat for bids and other wildlife including butterflies. While I would like to see more native plants, even Russian Olives provide shade and shelter for birds. I'm sure you know that bird populations are crashing and I'd like to see the many species of birds that use the brush and trees along the river be able to continue to do so. I see many species of songbirds there that never make it to our yard a few blocks away. I am excited about more amenities at the park, and I hope the city ends up choosing ones that are compatible with preserving the bird population.

No new pavement, prioritize plants and green space. And clean up the river (no agricultural run off) so we can actually go in the water!

Removing Russian olives (and staying on top of regrowth!) is my top concern. An effort was made several years ago, but the "weeds" have returned in force! Russian olives affect views, access to the river, cause allergies in many people, and offer places for homeless people to camp. Another concern of mine is the maintenance of weed and grass overgrowth. The fires in Medical Lake where suburban houses were burned to the ground was quite alarming to me. In years past, the City has cut the weeds next to the houses and between the walking and bike paths. While I understand that there are people who want to make sure wildlife habitat remains (I do too), I think doing nothing is not the answer. We have had fires on Bateman Island and the Yakima Delta. It is definitely a possibility that could happen in Leslie Groves Park.

Love the park. Keep nature.

I'd love to see some native species garden areas underneath trees in the space between the walking path & bike trails. I'd love to see the space between the river & the walking path restored to native plants & wildlife/bird habitat.

We need to reduce the restroom vandalism and partying/trashing in the parking lots. We need to have cameras outside the restrooms so we can identify who is going in and committing vandalism. We could install automatic timed locks on the restroom doors that lock people from coming in after dark but still allow anyone inside to exit.

We need to reduce the number of feral cats living there that prey on the birds. There are hardly any quail left in the park. People have set up feeding stations in the russian olive thickets. Animal control needs to trap the feral cats and spay/neuter. There should be a fine for those that feed the feral cats - when caught they have to adopt 2 of them and take them home. Again wildlife cameras can be used to identify the people feeding them.

Leslie groves is already a beloved part of the community and these proposed renovations will only make it more so. I've been coming to the park since I was a kid and I'm glad to see it getting the attention it deserves. My only concern is the disturbance of natural habitats, but the plans to remove invasive species and cultivate native ones have assuaged that fear. I look forward to continuing to enjoy this park with my friends and family.

Would appreciate repaving the walking / biking trail. Would appreciate more access points to the river from the walking trail (eg for Dogs to play fetch when the cyanobacteria isn't there). Signs noting last testing for cyanobacteria at each river access point.

Better maintenance of existing facilities.

I use the park frequently to walk, walk my dog, and occasional bike riding. The park gets a lot of use by a lot if people, as-is. I believe a strong case can be made to do nothing other than some increased maintenance and security to prevent vandalism to the bathrooms.

We pay to have public bathrooms- keep them open- always!!!!! They have heaters so don't close them in the winter and say it's for "winterization". Put up security cameras if you're worried about "vandalism ", that's just another lame excuse for not taking care of what I pay for.

As an avid fisherman, this park is not a good access point for fishing docks. Waste of effort to install in such a shallow area where target game fish species do not hang out. Only thing you'll likely hook are juvenile salmonids we should not be targeting. Might catch a bass now and again, but again this water is not prime fishing water.

Please only make minimal changes to Leslie Groves Park. We who use this special park every day want to keep it a quiet, peaceful place to enjoy for relaxing walks, jogs, and wildlife viewing. Yes, improve river views at the existing benches and add some fitness stations along the way. But no, please don't add more parking lots, and no Bike Skills Course, which will be noisy, dusty and scare off our precious wildlife. Many of us have made these comments on sticky notes at all three of the public meetings and they are always ignored. So, once again, please, we request no new parking lots and no Bike Skills Course. This area between the river and the homes is a wildlife buffer area that must stay natural and is critical to the health and well being of both our citizens and our animal friends.

Creating a way to calm traffic is essential. I live right on the Park Street entrance to Leslie Groves, and people speed way to much. And given the rowdy behavior at the volleyball courts, park security should also be prioritized.

I would also encourage the Parks Department to coordinate with the RPD, working with police to keep the park and adjoining neighborhoods peaceful by enforcing the noise ordinances of our community.

Avoid Pickleball courts. Too much noise that would change the calm, serene nature of Leslie Groves Park.

DO NOT RAISE MY TAXES AGAIN!!!!!!!

Cut out the space for homeless camps and for heavens sake, spray for spiders!

The Richland Police should make Leslie Groves a regular drive through during busy summer months. Also for each tree that dies or is ill, a new tree should be planted. Clearer markings should be added for walking and bike paths to keep walkers and bikers/scooters seperate.

Design to reduce homeless and drug dealing

I would love to see "Adopt" an area of the park available for thorough seasonal cleaning and maintenance from area groups. What types of lighting or gated closures have been discussed for nighttime security? Will there be easy sight visibility in the playgrounds so that parents can see children without them getting to the river? Is there a way to secure a playground for younger children so that can't get out in multiple directions?

Consider starting an "Adopt A Trail" program. Or "Stewards of Leslie Groves".

I love the idea of making a grove of beautiful trees, particularly at the south/middle part of the park. I would name it "Leslie Groves Grove". I love the idea of embracing the fruit connection to the area. Would be cool to have community fruit orchard.

I believe Leslie Groves could be the "crown jewel" park in Richland is currently underutilized, particularly with the huge amount of land between the bike path and houses from near McMurray to Park Street. There could be a splash pad, bike skills course/pumptrack, orchard, community garden, etc.

I'd like to see more garbage cans, and litter pick up. Recycling too. I'd like to have safe shelters for homeless people to sleep in.

A nature center building would be better at the Reach.

Have been going daily for 19 years. It is fine the way it is and we should lower utility bills and provide affordable housing for our citizens BEFORE we "improve" upon it with pickle ball, beaches and volleyball. It's quiet and we like it that way.

Needs more trash cans, additional picnic shelters

the barriers on the paths are so important because people drive their cars and trucks on the pedestrian and bike paths. Please do this!

nice large lighted bathrooms with security cameras please.

Do not try to bring thousands more people from Kennewick and Pasco to our parks! Keep parking limited so that locals can walk or bike there, but have handicapped spaces for those who can't.

Currently there is lots of noise created by people partying at the park, leaving trash, and disrupting the serene environment. I am concerned about the added influx of people creating even more disruption, traffic, noise, and trash. With more people, there are more bad people - I am concerned about the safety of our neighborhood.

Years ago the city took out most of the trash cans along the walking trail, so people with dogs had no where to deposit their dogs poop bags. As a result, many no longer pick up after there pets, or leave the poop bags on the side of the trail.

I am also concerned about property values/taxes. Last year my property taxes went up 18%. The cost of so many improvements, and future maintenance will certainly cost the city (and property owners) more money.

I am also concerned about how the "improvements" will disrupt my natural views and property values.

Children need more wild spaces. It would be wonderful to see opportunities for Sagebrush steppe exploration incorporated into playground design, such as scavenger hunts and kid-size signage through a sagebrush-laden field. I have fond memories of roaming sagebrush fields, climbing boulders, and finding critters when I was growing up. Children (and adults) are increasingly disconnected from truly local native spaces. The planned interpretive signage for adults is just a starting point. Bringing the genius loci of the Columbia Basin into kids spaces is the next step in the evolution of playground design in the Tri-cities.

It would be good to have officers patrol on bikes or motor scooters. Make sure that root heaves on pavement are leveled for runners, walkers or bikers. These cause fall injuries.

Please enforce leash laws-many dog owners won't walk their pets in LG because of off leash dogs. We would have more dog walkers if we keep the rules we agreed to and stop letting people pick and choose which rules they want enforced. We need bike police patrols.

Need more trash containers; need recycling containers; need bike racks; need law enforcement to control speeding vehicles to and from the park, especially on Harris Avenue and Newcomer Street; park maintenance vehicles should not ride over native areas - - stay on paved trails. Improve (not expand) current parking lots to discourage automobiles from riding and parking i the park! Control motor bikes and motorcycles from using the nonmotorized paved trails in the park.

These proposed changes affect only 3 summer months/year. There are not enough park rangers. During summer, trash cans over flow, increased traffic/speeding down Saint & Harris,. Native vegetation along the river is home to porcupines, red tailed fox, coyotes, skunks? Raccoons, pheasant, wild turkeys, eagles in winter and other water fowl. Increasing viewing access to river destroys the animal habits! How many more trees are you going to remove? How much of the grassy area will be removed to accommodate a nature center(LOL - isn't that why the Reach museum was created?) or to paved over for pickle ball courts? Kids come to grassy area to play soccer & ultimate frisbee, cross country races . Neighbors along Harris do NOT want more cars & traffic & crime or their pristine natural park changed into someone's pet political project (like the proposed dog park years ago!) How many of you who will make decisions actually live here & are intimately familiar with Leslie Groves?

Park maintenance is a joke. Current paths (Haines dike, etc) should have been condemned long ago. So called "wild areas" are a jungle of broken trees, debris, invasive weeds, etc. Structures are placed in places where they are not used or interfere with activities like Cross Country races.

Would like to see majority of park space dedicated to native species instead of grass

Less lawn. More pollinator and people pleasing native plantings that enhance and support biodiversity. Consider meadowscaping for larger swaths of proposed lawn areas that are drought tolerant, use less chemicals/inputs and require less mowing + maintenance than traditional lawns. Consult with your local conservation district, native plant nurseries and native plant society to learn more about plant selection. Vegetation along our waterways is important. Shrubs and thickets provide shade that help counteract things like higher water temps which foster toxic algae blooms and negatively impact salmon and humans. Clearing our shorelines of these microclimates would be detrimental to the health of humans and our avian, animal and aquatic friends.

Hire more park rangers. I think there is enough work for these men and women to do that one ranger per park area would be just about right.

I am sure the nature center talked about will be under utilized and over graffitied. Use the Reach for those activities.

My main concern is there seems to be a love affair with concrete not grass, trees and native plants. If I wanted hard scape I'd just walk around down town.

We have lots of manicured areas already. We should keep some of it more natural and wild. We need more havitat for birds, butterflies and other wildlife, not pickleball courts.

I like the natural areas in Leslie Groves park and would not like to see those disturbed.

It looks like this is a plan to make Leslie Groves look like Howard Amon. When I go to walk the river, I head for Leslie Groves, not Howard Amon. I'm a birdwatcher now, but that was my preference even before I started birdwatching. I'm not a fan of manicured city parks with lots of sod, beaches, etc., especially next to the river. That is very important habitat for a very important river, please don't screw it up. If you want to replace some of the invasive plants with native vegetation that would be great, but please don't tear out the riparian zone vegetation.

Figure a way to stop vandalism and KEEP THE BATHROOMS OPEN!

Leslie Groves at Park-Saint St is already over utilized. People enjoy walking on the paths here. We can use more trees but don't further disturb the natural areas. No more noisy activities crammed into this narrow strip of land. Those ideas also disregard the homeowners who already live there, as do extending parking behind existing homes. Respect the taxpayers who already live in this neighborhood and don't want the additional traffic and noise. Do not waste peaceful river views on bicycle courses and noisy volleyball courts. Put these amenities in a park that isn't accessed directly through a neighborhood, like Columbia Point for example, or Badger Mountain.

I am quite concerned about overnight camping in the trees by the river. When we local residents are walking the paths in the early morning, it feels unsafe to have people camping there.

Definitely do not want increased parking at Newcomer, and want traffic control. At a minimum, install stop signs at Newcomer and Harris so cars do not speed down Harris unimpeded.

I have interviewed people walking along the river and I could find no one who ever felt insecure there. None of my neighbors who walk there every day have ever said they feel insecure. This is a made-up issue.

Traffic calming on residential streets with park access is the top priority, especially if additional parking will be created for increased park access. Vehicle speed should be physically limited to 20 mph by speed bump or other measures for anyone accessing the park in a motorized vehicle.

Security needs to be enhanced around the restrooms year round. Having access to restrooms is a real need for both older folks and small children when visiting outdoor parks.

Maintenance of the new expanded park facilities will be critical. Construction will need to take into account existing park usage. More trees will provide expanded opportunities for families to recreate together. Thank you for this planning effort and taking our input into account!

Bathroom monitoring could be addressed. Repeated closures due to vandalism is an inconvenience for many who use the path and park.

Public restrooms need to be available along the extent of the walking & riding path. Our taxes pay for the upkeep and care. Randomly shutting facilities is unacceptable. We understand that there are vandalism issues with some locations, but not changing your approach to these issues is not a solution.

Traffic is heavy at weekends, with speeding cards along Harris Avenue - a residential area.

Parks are unused for majority of time - only heavily used in summer weekends. Better to expand Howard Amon parks, closer to town, closer to facilities to handle the crowds

Trash is an issue now at the park. What better maintenance and trash pick up. Want a gate that locks the parking lot at night and lighting in the parking lots and trails for security.

I lived in front of Leslie groves park from 1973 until I graduated college. My mother still lives there, in that same house. The most precious, irreplaceable parts of the park are those that contain habitat for birds, otters, beavers, etc. I would love to see native species (sagebrush etc) planted and tended in the parts of the park where nothing grows right now. And I would hate for these natural areas to become human-focused. The tri cities is losing shrub steppe habitat at unbelievable speeds... we should nurture those places where there is an opportunity to reclaim them. I would love to help.

e-bikes are a menace to walkers and dog walkers. They must be controlled or limited somehow. They go way too fast!

No. more parking lots. The existing parking lots are sufficient, with overflow to Harris and Park Street. Existing Harris Ave owners do not want a parking lot in their back yard. Do not add features like exercise stations that will not be maintained. Put more emphasis on maintaining the vegetation and pathways. The current path ways have not been maintained well and have significant cracks that people. have tripped on or fallen off their bikes. There are multiple faded paint markings where it has been identified by the city to fix these cracks for years, Vegetation along the path almost always currently infringes on the path. I will commend the pruning of the trees between the bake and walk path, but I suggest that the vegetation has been overgrown over the summer. In the Leslie Grove park middle, the city killed all the native grass so all that is left is tumbleweeds............ Please put more emphasis on maintaining the path vs capital improvements that will not be maintained!

As a resident, I would love to see better pest management for the spiders that come late summer/early fall
The trails are getting dangerous for bikers where tree roots are lifting the pavement. This caused me to crash and have to go to the E.R. recently (I'm also pregnant so it was very upsetting.)

3) I would love to see trees replanted when others are torn out due to disease/etc.

4) I love the idea of removing invasive species and planting native plants, but would also like to see native plants with some more color so that it looks intentional and pleasant.

Leslie Groves Park represents a unique opportunity to blend natural resources with the local community. The park provides great habitat for native flora and fauna including many species of birds and mammals. This opportunity should be a key point of emphasis for the development plan. The plan should be shaped to improve not degrade the natural habitat and should include:

- Removal of invasive plants
- Reestablishment of native species
- Features to increase the diversity of plant and animal species (eg. bluebird houses)

Revisions to parking lots appears a number of times in the plan. Current lots are adequate to handle most current conditions and on rare occasions when the lots can not handle the load Harris Avenue easily absorbs the overflow.

I could not find much relevant information on the Bike Skills Course. I believe this feature should be fully described and evaluated before it is included in the plan.

What environmental documentation is required?

No new parking lots!! Keep the land natural (no concrete). Parking is adequate with overflow onto Harris Ave. More money should be put into maintenance of the paths and vegetation.

Cars drive too fast on adjacent streets. Bathrooms could be better maintained.

We need gates to close at night. We need a dog doo service We need greater trash pickup more frequently We need more parks in other areas of Richland Spread this joy Keep our parks and streets safe

For personal reasons I would suggest improved handicap restrooms.

Why add exercise equipment when what is there has been allowed to decay over the years?

Please no more concrete at the parks!! More trees and green space would be wonderful.

I think the park is well maintained and secure. Potentially adding some lighting along the walking path would be nice during the fall/winter months when the days are short.

Clearing brush and trimming trees adjacent to the walking and biking path would be very nice. Thanks.

Please remove all motorized bikes from trails along the rivers - I have seen an increase in reckless behavior with people who do not have sufficient bike skills to ride in crowded areas.

The walking trails overgrowth could be maintained more frequently and during the times when spider webs overrun, more frequent maintenance would help.

There are people living in cars, rvs, lurking by restrooms

Removing Russian olive will be a massive and ongoing task that will require annual maintenance, those things keep coming back, quite invasive.

Somehow prevent non-City vehicle from racing on bike and walking paths at night. Do not plant more trees until you eradicate the Russian Olive trees -- that should be priority one, and it will take some work in years one and two and then annual focus/effort every year.

Please DO NOT build the proposed nature education space in the north part of the park. We already have a hard time keeping existing structures (the tennis backstop, for example) free from graffiti and other forms or vandalism. As a homeowner on Harris between Saint and Snyder, I see plenty of activity by people driving their cars fast and meeting up to do, presumably illegal things, in the Snyder boat launch parking lot at night and there is just not enough police patrol presence (really none) that would discourage vandalism of a building in that location. Also, we already have two tennis courts at the Saint end of the park that are only used occasionally. We do not need additional courts and we certainly don't need pickleball courts. Can't the two share? A renovated basketball court in its current location would be fine, but that is also hardly every used. Leslie Groves is already a beautiful park. Please don't ruin it by adding an amusement park feel to it. Leave it quiet.

Yes the native plants on Harris off of Snyder impede the roadway to an extent it makes it hazardous to walk and or drive with walkers or bikers on roadway. The vegetation management would really enhance so much of the park and I hope that by cleaning the shoreline area and trails will provide safe areas. There is also concern about the vegetation by the river being a place for homeless camps.

Seems to be well maintained and safe

My primary concern is preventing homeless people from camping out in the park.

Absolutely imperative to increase / improve trash receptacle availability. Ensure restrooms have functioning hand drying machines!!

More garbage cans and recycling. I don't ever feel unsafe in the park. We don't need security except for terrible drivers.

It's only the peak summer months that park is very busy and the residents close by have to deal with loud radios, more garbage on grass and very loudc cars speeding down Harris Ave as they leave. Mire parking is NOT the solution. Police presence at dusk would help!

Endangered Monarch butterflies use the riverside area from the volleyball courts to the south end bathrooms. I strongly feel this entire area should be left as is to continue to provide the habitat they have selected. Other pollinators and rare insects and plants have been found in this area as well. Strongly believe adding river access at Newcomer will disrupt habitat and their desire to use this area. If it's occupied and paved over, they will leave. We have valuable habitat that needs to be recognized, preserved and valued!

The proposed plan of additional parking lots are a security problem. The existing parking lots are enough and need to be updated and fixed. They are seldom patrolled unless something happens. What is already in the entire park needs to be updated and cared for before any additional recreational items are added.

love this park. need to upgrade trees

Richland parks are generally very well maintained but I wish there were better (any?) enforcement of leash laws. Parks should also have blue bins for recycling options near heavily used picnic areas. Staff works very hard on Monday mornings to clean up the mess left by weekend picnickers so more garbage disposal options are clearly needed.

I'd like for the homeless people in our community to have a safe place to live.

Maintenance, maintenance, maintenance.

Lights activated by motion

More open spaces and native plants would be incredible

The natural habitat that both native & exotic trees and shrubs provide may also provide habitat for homeless people, but that is not enough reason to devastate them. Light pruning is not an issue, but the aggressive work done recently severely reduced habitat for insects and birds.

Keep the water fountains on all year, keep bathrooms open all year, add more bathrooms or.improve what exists, better signage on bike/walking lanes

Richland's biggest asset! Trails need some maintenance for tree root cracking/uplift. Appreciate your work on this!

My main concern is that the russian olive trees and willows are growing and blocking the view of the river on the walking trail in south leslie groves. These also provide abundant space for homeless people to camp and leave trash, which is against the park regulations. It also poses a security hazard as it would be easy for a criminal to abduct a person / kid and assault them in the vegetation, out of view of the people on the walking trail. We won't let our kids go walk on that section of the trail without adults.

Richland Really needs an outdoor rollerskating rink like kennewick. While our rollerena is awesome, it has limited hours. Having a pump track would also be an awesome addition to Richland.

WOULD LIKE TO SEE SOME SORT OF LIGHTING ALONG THE PATH FOR INCREASED SAFETY. WOULD ALSO LIKE TO SEE AN AREA FOR FOOD AND DRINKS.

Please provide greater patrols for regular vehicles taking marked spots near launch for boat-trailer parking - particularly during the summer months.

1. Need stop signs for cars at River Road and Snyder before the pedestrian/bike paths. Both are dangerous, blind intersections. 2. Do not want to see habitat destroyed along the river to discourage the homeless; better

would be a more proactive approach in providing housing and mental health treatment for the homeless. Pet peeve for the neighbors north of Snyder Street - by not allowing homeless in the developed parts of the park, the City has effectively moved the homeless population to north of Snyder Street along the river. 3. The river shore is an important habitat area for pollinators, birds, and other wildlife; more lawn areas are counterproductive. Leslie Groves park has always been unique among the Columbia R. parks as more of a habitat area and should remain so, with improvements to the habitat. Restrict developed areas to between the current beach just south of Park St. to Snyder. If an ADA accessible dock is desired, put it adjacent to the current beach.

I think Leslie groves area is a treasure as is. It should be left alone. I especially the native garden and that it has been a grass roots effort labor of love. It makes me sad to see administrators and organization leaders grab hold as I believe they will ultimately destroy the wild beauty built over many years by mostly retired citizens.

Please discourage feeding of feral cats in park. We need self locking doors at the restrooms. Lock at dusk. Open at dawn. Video survelance of park restrooms to prevent vandalism.

Occasional sweeping of the paths to remove rocks and debris.

Bicycle maintenance station, though well intentioned, is of limited value and will probably be a target for vandalism. Even if not vandalized, will need to be regularly maintained to be if any value. Suggest eliminating it.

One major problem on bike path is tree root incursion. Any plans should address minimizing tree root incursion.

Leslie Groves is my favorite park in Richland. I'm excited it's getting a bit of attention. I'm especially excited for the clean up of invasive plants and adding more trees. The large trees aren't going to last forever and we need to start some new ones! I love that central Leslie has so many activities and is full of hustle and bustle, but it's also nice that north Leslie is calm and quiet. We enjoy being active in the tennis courts, and relaxing in the benches and watching the river wildlife.

Need a better playground with coverage for shade. Leave some open grass space. Another dock or for people to walk on (no boats) would be nice. Do not want another beach/volleyball area. It's always loud and filled with obnoxious people who don't live in this area and treat the park like a dumping ground.

Love, love the idea of adding non-motorized kayak/SUP/Rowing access at newcomer.

Please reduce speeds on Snyder st, and add more 4 way stop. Snyder and Davison, and Snyder and Harris need 4 way stops. Trucks pulling trailers drive dangerously on Snyder. There are many kids in this neighborhood. Traffic safety is very important

Maintain the trails, they are badly damaged by tree roots. Add proper bike parking (U-shaped racks, not the wave racks). There is no bike parking near the beach, so when I bike in my inflatable kayak the only place to lock is the bench.

I think you are fishing here for anti-homelessness NIBMYism, but frankly, the City of Richland provides no

services to people who are experiencing homelessness and people need to go somewhere. Instead of making the librarians and our parks department the de facto social workers the city should address the growing need for sheltering people, including families and mixed-gender pairs. Since we moved here in 2016 there has been a mother-son pair who have been unsheltered because he is her full-time carer and the only shelter they could go to would split them up. People deserve to live with dignity.

Waking paths are being overgrown from river side weeds and trash bushes

Ban all motorized conveyances. Motorized bikes and other battery supported are now too fast. Make bells for warning approach mandatory. Do not have separate bike and pedestrian paths. This park should be for those who want to casually walk and enjoy nature, not for those who want to race through it. Let the racers use the streets.

nobody goes through the park and picks up trash before the big mowers go through so plastic trash is chopped up into little bits and spread everywhere, this is part of why microplastics are now ubiquitous in our environment

Security cameras and enforcement would be a great addition.

Gates at parking lots should be shut and locked at night. Homeless vehicles have begun camping in the parks. Paths for biking and walking should be cleared of overgrown weeds, brush and trees consistently. The view of the river along the "river view " path should be visible. Russian olives and brush need to be kept cleared with constant maintenance.

Experiment with more effective security approaches to allow restrooms to remain open year round.

Rather than add parking, add more traffic enforcement, bus stops, and optimize/repair the lots we have and control traffic. Perhaps the restroom access to library cards and rfid? Lean into the connectedness of the community and disincentive driving everywhere.

I think I'm less worried about security and maintenance as I am about pedestrian access to this trail. Its difficult to get to this trail if you live deeper into the city. It would be more helpful if there were protected routes (protected from motorized vehicles) for bikers and pedestrians to GET to the trail. It would see a lot more use if there were public restrooms. I cant tell you how many times I've been on a bike ride and had to go but theres no public restrooms at the parks. It would also be nice to have public air pumps for bikers. The goatheads are lethal.

Also -- please stop trying to make the city more efficient for cars. We need to start building cities around easy, walkable or bikeable access.

ALSO, please start RAISING cross walks, so that cars have to slow down in the city where there are people walking. It is not hyperbole, when crossing G Way -- if I dont look out I will get hit, even when I have the crosswalk. Itll be safer for everyone and save lives -- thanks.

I use a mobility scooter, and like to ride with my husband while he walks. The gaps in the walking path south of the sand volleyball courts are extremely difficult to navigate with the size of wheels on scooters. PLEASE fill in the gaps to make it more comfortable to use! Also, please make sure any new paths are paved - it's very frustrating for disabled individuals to be unable to use level paths due to unpaved, soft surfaces.

Parks seem safe. Don't use security as reason to destroy habitat.

There is only one dog park in the tricities, let's change that!

Nothing further - very clean and well maintained!

Definitely need to make bike-only and pedestrian-only trail signs a LOT more obvious!!

If restrooms were maintained and open even at dusk, that would help me take longer walks in the evening. Right now I'm limited because the bathrooms are sometimes closed, and I would like to walk at sunset and not worry about it.

Patrolling to ensure safety and health of residents

Security is a non issue. We need more multi use areas in our parks. Dog park, nature/adventure play for kids. Fewer large open spaces, more activities (dog parks, obstacle courses, amphitheater, etc).

The vegetation over growth along the north and south portions of the walking paths has made me no longer feel safe jogging through those areas alone. I have had people come out of the brush trying to approach me/yell in the early morning hours. I no longer run in the park. The south nature area in the worst. Also remove the rocks lining the path on the north end. It makes the multi use path too narrow and I trip the rocks navigate a group of people walking and tripped over the rocks and fell. Got banged up really good.

As someone living on Snyder, I want to make sure we keep our neighborhood streets safe and quiet. There is already a lot of speeding and racing related to the park.

Overall great. Would be nice to have the shrubbery trimmed along the river trail, especially the thorny shrubs.

Also more trash cans around the sand volleyball area (by Park St). And more dog waste bag dispensing stations please. Currently we have one at the Snyder Boat Launch and one at the beach, but they are not well stocked.



easy access to the river. Model it after Pascos side of the river across from Columbia park...their side looks great and they take pride in their parks and river views...Richland, not so much.


8. HOW CLOSE DO YOU LIVE TO LESLIE GROVES PARK?
